## 2. Terms and Conditions:

- d. She will hand over her duties with consent of the authority;
- e. There will be no financial involvement of BCSIR/GoB in this travel; and
- f. According to Section-34 of Appendix-8 (Rule-234, Note-2) of BSR Part-1 the leave will have to be commenced within 35 days; otherwise the leave will be void.
