



Government Order

The undersigned is directed to convey the sanction in favour of Seema Rani, Senior Scientific Officer, Bangladesh Oceanographic Research Institute (BORI), Cox's Bazar to participate in the Seminar on 'Global Climate Change, Blue Economy, Delta and Water Resources Management' to be held from 13 April 2024 to 19 April 2024 in Japan or nearest possible time (excluding travel time) under the following terms and conditions:

 - e) After completion of the Seminar, she will have to submit a report to the Ministry of Science & Technology within 15 days.


