3. Terms and conditions:

- a) While participating the program (including transit), they will be treated as on duty.
- b) They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency.
- c) All the expenses of Serial no. 1, 3 & 4 of the delegation will be borne by Construction of Rooppur Nuclear Power Plant Project, Bangladesh Atomic Energy Commission. The expenses of Serial no. 2 of the delegation will be borne by Development of Nuclear Regulatory Infrastructure for Bangladesh Atomic Energy Regulatory Authority to supervise the Nuclear Safety of Rooppur Nuclear Power Plant Project, Bangladesh Atomic Energy Regulatory Authority. The expenses of Serial no. 5 of the delegation will be borne by Nuclear Security and Physical Protection System for Rooppur Nuclear Power Plant Project.
- d) They will leave Dhaka for Mumbai on 19 November 2023 or on a nearby date and will leave Mumbai for Bangladesh on 22 November 2023 or on a nearby date.




