Subject: **Permission to enjoy Earned Leave as Ex-Bangladesh Leave.**



The undersigned is directed to convey the Government's approval to enjoy Earned Leave as Ex-Bangladesh Leave in favour of **Dr. Dipa Islam**, Principal Scientific Officer, Biomedical and Toxicological Research Institute (BTRI), Bangladesh Council of Scientific and Industrial Research (BCSIR) for travelling United States of America (USA) on account of her own medical treatment for cancer from 11.03.2024 to 09.04.2024 or 30 (Thirty) days from the date of departure under the following terms and conditions:


