 - d. All expenses of this program will be sponsored by The Pennsylvania State University, USA. There will be no financial relation with NIB or the Government of the People's Republic of Bangladesh;
 - e. She will have to submit a report on the program to the Biotechnology Cell of the Ministry of Science and Technology (MOST) within 7 (seven) days after her return from the program.
 - f. The provisions of the Public Administration Training and Higher Education Policy, 2023 will be applicable in connection of this approval.
